Legislative Update 2017

The first year of Vermont's 73rd Legislative Session is coming to a close. It was a relatively slow start compared to past recent sessions. New leadership, a new Governor, Lt. Governor and a record number of new Representatives caused the committees to take more time to orient members. As time went on, bills have been flowing and we are now getting a better idea of how this year will turn out. One of those new legislators is VASA Director and Treasurer, Gary Nolan of Morris-town. Rep. Nolan serves on the House Transportation Committee, a very important committee for ATV uses and trail policies. We are very fortunate to have him there and he has already made a difference on our behalf.

Governor Phil Scott made it clear he was opposed to any new taxes or fees. His administration did not propose a fee bill or miscellaneous tax bill as is the annual custom. His "line in the sand" worked. The House passed the budget, a small tax housekeeping bill and a transportation budget without raising any taxes or fees. The Senate did attempt to raise a small \$2.00 per room, flat Rooms surcharge, but the day after the vote in the Finance Committee, the measure disappeared. The Senate is soon presenting their response to the House passed budget, capitol budget and taxes and do not appear to be very far apart. The session is expected to close in early May.

There were a number of bills that came onto the watch list mostly housed in the transportation and government operations committees. There were also a few bills of interest dealing with

agriculture and forestry that impact landowners.

H.287 -Ways used for vehicular travel; property; torts; duty of care. Introduced by Rep. Hubert of Milton whose grandson was seriously injured by a cable that appeared across a road that he regularly traveled. The bill requires a landowner to hang flagging or reflectors from a cable, rope, chain, pipe or other temporary barrier across a way in which the landowner knows or should know is used for vehicle traffic by the public. Vehicles are defined to include ATV, snowmobile, bicycle or watercraft. The bill is in the House Committee on Transportation. Landowner groups and recreational interests oppose this bill as it appears to lower landowner protection from liability for persons on private property. Representative Gary Nolan, also a Director of VASA, paid particular attention to this bill as landowner and recreation groups expressed serious concerns about the unintended consequences of landowners choosing to post their land to exclude all lawful uses of the public. Ed Larson testified on behalf of VASA and the Vermont Traditions Coalition. In response to strong testimony from several groups, Committee Chair, Pat Brennan presented a new draft that directs the Agency of Transportation along with the Commissioner of FPR and F&W to develop a paper, (brochure) to distribute to landowners describing the dangers of cables, chains and wire across a trail that is not easily visible to travelers on vehicles. A big win for maintaining current landowner liability protections. Chairman Pat Brennan deserves a great amount of praise and credit for the work he did to find a solution based on education rather than regulation. Representative Hubert also needs to be recognized and acknowledged that his intent was to find a way to prevent

what happened to his grandson, to not happen to someone else.

Hubert continued to amend his bill to address landowner concerns as he also wanted to avoid a reaction by landowners to exclude public access. In the end, Hubert supports the new education approach as a good step forward. This language was added to S.127 a miscellaneous transportation bill.

H.231 - Authorizing municipalities to prohibit through traffic by heavy vehicles. Housed in the Committee on Government Operations, the bill gives municipalities the authority to prohibit large and heavy trucks and trailers from using a class 3 or 4 town road to shortcut through an area. The exception is for local stops. Of concern is if there is a need to use this road to access a trail or build a trail, transporting equipment using heavy or large trucks and trailers also needs this exemption. In response to my concern, the sponsor of the bill does not object to adding language to assure that is an allowed use of the road. There was no testimony so this bill is not moving forward this year, but the lead sponsor Representative Peter Fagan of Rutland is hoping to make this a priority bill next year.

Another bill popped up late in the game that created some concern is H.39. This bill reduced the one acre impervious surface trigger for a storm water permit to go down to one-half acre. The bill moved late and is stalled in the House Ways and Means Committee, at least for this year. It is not certain that this will impact trails, because there are exemptions in place, but we will be paying careful attention to this measure if and

when it is taken up again.

A Miscellaneous Transportation bill, S.127 passed the Senate and is working its way through the House. The bill has several technical and housekeeping changes to a number of DMV laws. Of interest to VASA, Section 17 deals with the transfer of registration to a surviving spouse of vessels, snowmobiles and ATVs. It allows the registration to be transferred upon request to a surviving spouse without any fees. It also creates a default in that if there is no specific request in a will or trust, these vehicles will automatically transfer to a surviving spouse.

An important bill regulating certain large forested parcels may still be in play. H.233 creates different triggers for development in these parcels and require an Act250 permit. These parcels are classified as a highest priority interior forest block or a highest priority connectivity block. The committee is reviewing a new proposed amendment that removes the new triggers and requires a review under the permit to minimize or mitigate fragmentation in mapped "forest blocks". According to maps created by ANR, these parcels can be widespread across the state and it is almost impossible to know if your land is classified as such until you decide to subdivide or develop. The Vermont Forest Products Association has taken a strong position opposed to this measure. It has missed the crossover deadline, but Chair, David Deen, of the House Committee on Natural Resources, Fish and Wildlife continues to work on the bill.

Management Plans for State Lands

This past fall **The Victory Management Unit (VMU)** has completed its plan update. VMU is approximately 24,000 acres across three parcels: **Victory Basin WMA, Victory State Forest, and Darling State Park**. Ed Larson attended both hearings to assure there remains good connector to trail language as requested by VASA. The Agency of Natural Resources started the scoping process of updating the management plan for the **Aitken State Forest**. Purchased in 1912, the 918-acre state forest is in the town of Mendon. This State Forest connects to the newly created **Jim Jeffords State Forest** which connects to the **Coolidge State Forest** so there is now a very large 25,000-acre block of forested public land in Rutland County. A draft plan is expected in late 2017 or early 2018. Ed Larson attended this open house along with **David Noel from The West Rutland ATV Sportsman's Club**. We offered to partner with the planning team and expressed the desire to include connector language.

The long-range management plan for the **Castleton Management Unit** including both **Blueberry Hill WMA and Bird Mountain WMA** is under revision. Natural resource inventories and assessments that serve as the basis for planning are underway. An initial public scoping meeting will be held prior to the development of the draft plan once inventories are complete. This unit is just under 1300 acres in size.

Willoughby State Forest is reviewing comments and making decisions on a proposal to enhance parking and use in the south end of the lake. We are also expecting a notice to begin the scoping process for the long-range management plan on this 15,000-acre

state forest. [This forest contains an excellent network of primitive roads that would serve as excellent connectors to any private trails on adjacent lands.](#)

Silvio O. Conte National Fish and Wildlife Refuge (Conte Refuge)

Final Comprehensive Conservation Plan is complete and is now seeking appropriated federal funds to implement their acquisition plans. In Vermont, the US Fish and Wildlife Service is seeking to create four additional Conti Refuges along the western side of Vermont. According to the plan, if all lands in this plan were purchased, would increase the size of the refuge by more than 60,000 acres. As you are aware ATV use is prohibited and if lands are purchased with an existing trail, they would move to extinguish those trails. Frank Stanley, Danny Hale and Ed Larson are working with the Vermont Forest Products Association, New Hampshire Timberland Owners and the New Hampshire ATV Club to build a coalition to protect our interests.


